SUBJECT: *URGENT CALL TO ACTION* — INVESTIGATION INTO THE CRIMINAL SUPPRESSION OF LIFESAVING RESEARCH THAT HAS ALREADY RESULTED IN THE DEATHS OF OVER A MILLION PEOPLE.

Dear FLCCC supporter,

We trust that this message finds you in good health.

We bring to your attention a matter of utmost importance that requires our collective focus and backing.

Dr. G. Umberto Meduri, a founding member of the FLCCC, has initiated a petition on Change.org entitled "**Suppression of Lifesaving Research and the Toll on COVID-19 Patients.**" This crucial petition highlights the relentless efforts of academic, pharmaceutical, and regulatory industries to suppress Dr. Meduri's groundbreaking research—beginning in 20001— on an affordable and effective corticosteroid treatment for acute respiratory distress syndrome (ARDS). ARDS, a life-threatening condition with a 40% hospital mortality rate, affects 200,000 patients in the US annually and is the leading cause of death in both COVID-19 and past viral pandemics.

Top-line facts regarding the intentional destruction of Dr. Meduri's Memphis Lung Research Program (MLRP).

- From 2002-2020, ARDS killed 80 thousand patients each year in the U.S. alone—and ten times that globally. A large percentage could have been saved with corticosteroid treatment—**which was intentionally suppressed.**
- In 2020, COVID-related ARDS killed hundreds of thousands of patients when they could have been saved with early corticosteroid treatment— **which was intentionally suppressed.**
- Early treatment with corticosteroids would have mitigated the social and economic costs of the pandemic. **But it was intentionally suppressed.**
- Progress generated by the MLRP's continued research could have prevented most of this. **But it was intentionally suppressed.**
