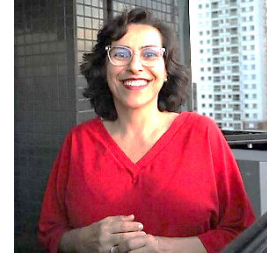

IV - Current Professional Activities

Works as a Medical Psychiatrist since 1990 in an outpatient private setting.

Also works as a Technical Consultant for lawyers, physicians, non-medical health professionals, public-health policy makers, and news media on the assessment of policy failures and mismanagement of COVID-19 pandemic, in Brazil and abroad, due to the misinformation campaign waged by public and private sectors led by shady conflicts of interest.

Participates in Bioethics Study Groups on COVID-19 prophylaxis and treatments, assessment of post-inoculation adverse effects, pandemia management, and its impacts on physical and mental health.

Coordination of Advocacy Groups for Professional Medical Autonomy and Social Actions in defense of Doctor-Patient Decision-making Freedom.

Organizes public hearings in Municipal, State and Federal Chambers and the Federal Senate on the effectiveness of Covid-19 early treatments protocols, the absurdity of mandatory “vaccination” and the risks and reported adverse effects related to inoculation with viral messenger RNA, instead of traditionally developed and carefully tested vaccines.

Participates and also promotes public hearings on the problematic UN 2030 Agenda and whether it has a vinculating effect according the International Law.

Participates in discussions and debates about the impacts on the public health of the excessive use of prescription psychiatric drugs and the effects on children's development of overmedication and vaccination, in correlation with the incidence increase of physical and mental illnesses (such as autism) in the last 40 years.

V - Personal and Professional Views:

Envisions a wider and deeper approach to Psychiatry in the 21st century as a great field of knowledge to be developed through a review of the paradigmatic premises of medical knowledge, in the light of the new findings and emerging fields of knowledge; such as neuro-endocrinology, molecular genetics, metabolomics, integrative interdependence between physiologic functions and

the environmental epigenetic factors. Those fields render a solid empirical evidence on the integrative nature of body-functions-cognition-emotions-immunity-beliefs-genes-and-spirituality.

Holds the conviction that a humane approach to the doctor-patient relationship should promote an emphasis on well-informed and shared decision-making, the development of an awareness on the prophylactic value of good habits, the principles of natural immunity, and the patient's active participation in disease prevention and treatment.

Only the search for truth can lead to the awakening of individual consciousness and a change in the destiny of humanity. We are preparing an International Campaign in this regard.
